DEAR COMMANDER KENNEDY:

IT WAS WITH DISMAY THAT I DISCOVERED YESTERDAY, UPON ASKING IF YOU HAD RECEIVED A VIDEO TAPE & LETTER LEFT AT THE FRONT DESK ON SATURDAY EVENING- CLEARLY LABELED "URGENT" IN RED MARKER- THAT YOU HAD NOT RECEIVED IT . I HAVE PUT TOGETHER A DUPLICATE PACKET OF MATERIALS CONTAINED THERE AND AM DELIVERING THEM TO YOU THIS AFTERNOON VIA A LIEUTENANT MCKENNA WHO HAS ASSURED ME THAT THEY WILL REACH YOU. OBVIOUSLY, THERE IS REAL SLOPPINESS AT THE FRONT DESK OF SOMEONE DOESN'T WANT YOU TO BECOME AWARE OF THE MATTER AT HAND.

I HAVE ENCLOSED A NUMBER OF MAGAZINE ARTICLES & NEWS ITEMS TO GIVE YOU SOME IDEA OF WHO MARSHA P. JOHNSON WAS IN THE GAY COMMUNITY. THE VIDEO TAPE OPENS WITH A 15 MINUTE INTERVIEW WITH OUR EYEWITNESS (0-1200). THEN YOU HAVE A BRIEF SEQUENCE SHOT AT THE MEMORIAL SERVICE FOR MARSHA (1215-1576) TO SHOW YOU THE 400+ PEOPLE WHO ATTENDED (INCLUDING MARSHA'S FAMILY) AND ALSO, BEGINNING AT 1576, MARJORIE HILL FROM MAYOR DINKIN'S OFFICE READING A LETTER TO THOSE ASSEMBLED (1576-1735) FROM MAYOR DINKINS HIMSELF.

BEGINNING AT 1735 YOU WILL SEE LIVE FOOTAGE FROM A HASTILY ORGANIZED SMALL DEMONSTRATION AT THE SIXTH PRECINCT LAST JULY 19TH. WATCHING THIS FOOTAGE, ESPECIALLY OUR CONVERSATION WITH DUTY CAPTAIN McSHANE (WHICH BEGINS AT 2800 AND ENDS AT 3263) WILL VERIFY THE ASSERTION IN MY ORIGINAL LETTER THAT A MEETING WAS PROMISED AND THAT THIS PROMISE WAS NOT KEPT. THE DEMONSTRATION ON THE 19TH WAS SMALL BECAUSE IT WAS CALLED ON A 36 HOUR NOTICE. MANY OTHER PEOPLE WHO WOULD HAVE COME SIMPLY HADN'T HEARD ABOUT IT.

I HOPE THAT THIS REACHES YOU. I DO NOT UNDERSTAND WHY I WAS DISCONNECTED SIX TIMES IN A ROW WHEN I CALLED YESTERDAY 10/7/92 TO VERIFY YOU HAD RECEIVED THE PACKAGE.

WHILE I AM AWARE OF ACTIVITIES OF OTHER GROUPS SUCH AS THE ANTI-VIOLENCE PROJECT REGARDING THIS MATTER, I MARCH TO THE BEAT OF MY OWN INTERNAL MORAL DRUM & DO WHAT I THINK IS RIGHT. I SINCERELY HOPE YOU WILL REVIEW THIS SITUATION, REASSIGN THIS CASE TO A MORE RESPONSIBLE DETECTIVE, HAVE THESE PEOPLE IDENTIFIED, PICKED UP & QUESTIONED & PUT IN A LINE-UP FOR MUGGING VICTIMS AS DEMANDED IN OUR PETITION.

OTHERWISE, I WILL FEEL COMPELLED TO PUT OUT A CALL FOR A STONEWALL II AND ASK MARSHA'S FRIENDS TO LAY SEIGE TO THE SIXTH PRECINCT THIS HALLOWEEN & ENGAGE IN WHATEVER PROTESTS ARE NECESSARY.
