W I L M A ' S V I E W S

WHAT HAVE DOCTORS TO SAY ABOUT TVISM? PERHAPS THESE THREE QUOTATIONS WILL SUFFICE TO ILLUSTRATE THE CURRENT STATE OF MEDICAL OPINION.

Dr. Alfered Eyerer (Dis. Nerv. Syst. 21, 52 Jan'60) says, "Effective therapy, formidable and difficult in any of the personality disorders, is, in this particular entity (transvestism) practically impossible. Any therapeutic approach relieving symptoms, tension, and discomfort and promoting better adjustment certainly is in order. Clearly understanding is the bed rock upon which adjustment can be built, understanding by the individual and by those near him.

Drs. Bowman and Engle (Amer. Jour. Psych. 113, 581 (1957) said, "It is generally agreed that all types of psychotherapy are a failure (as a cure for transvestism). So far there are no reported successful treated cases.

Drs. Walker and Fletcher, in the book "Sex AND SOCIETY" (Pelican Books) state: "When doctors are able to do so little for patients as we doctors are able to do for these cases of transvestism, it would be better for us perhaps to make efforts in another direction. Instead of treating the patients themselves, we might treat with more profit the society which makes it so difficult for these unfortunate people to live." Let us look at society's attitude.

It is commonly recognized that no man is 100% masculine and no woman 100% feminine. Since this is the case, every man has feminine qualities that seek expression and every female has masculine ones. Society allows the female to express her masculine aggressiveness, domination, etc. in various activities and allows her to dress to fit the part. Thus we have women soldiers and women policemen, bus drivers, riveters, motorcycle delivery girls etc. In all cases they wear clothing that is distinctly masculine but is suitable and proper both to their own inner demands and the requirements to the job.

But the male who seeks to express his feminine qualities such as gentleness, non-aggressiveness, submissiveness, compassion or artistic or domestic talents is frowned upon and made sport of. He comes to feel out of place in attempting to express the feminine side of his personality while in pants. Thus, just as the woman bus driver is more in harmony with her own desires and the needs of her job when she wears mannish attire, so the male seeking personality expression and freedom for the feminine aspect of his being, is more in harmony in a dress, makeup and high heels than when he is in pants. So he adopts all items of feminine apparel, makeup and decoration because his feminine side is "living". The male should be entitled to emancipation and freedom of expression just as the female is.

It is important to point out that just as the woman bus driver may still be a good wife and mother when off the job and back in her feminine clothes, so the male transvestite does not sacrifice or imperil his masculinity by his transvestic activities. He is still an adequate male, father, and husband. Wives and parents who can come to understand this fact would discover that the person involved was really a much broader, better and more understanding human being precisely because of his "double gender" than he might otherwise be.

What are transvestites like, and how could you tell one? The answer is that you couldn't! Transvestites do not come out and admit their interests-- due to fear or ridicule and false accusation they keep it a secret. You wouldn't know a transvestite if you saw him because on the average he is married, usually a father, and is well integrated into society. He is effective and adequate in his business relationships and to all intents and purposes is a "regular guy". But many ~~strained~~ a home has been broken and many a child-parent relationship has been badly strained by discovery or revelation of the fact of transvestism in husband, son, brother, father or friend. When people have insufficient knowledge they can not know and understand. When they ~~cannot understand~~ are afraid they are cruel. Such is life.

NYLONS: For those like myself who have rough hands and are prone to be careless at times when putting on their hose and do not have a pair of gloves handy, I've found great success for getting longer wear out of my nylons by using a sock on each hand when handling your hose from the time you pick them up, until you have them on. I've found that I have saved myself a few pennies by using these socks, and did not find any difficulty rolling them like dough-nuts to insert the foot into the toe section of the stocking, and also I found I could pull them up firmer to give a very good appearance. Even when washing your hose you can feel more secure not to damage them wearing the sock on each hand. Though the sound of this seems odd, I'm sure once it's tried the value of it can be realized.

Identification Cards by Micheline [REDACTED]

If you travel as a woman, and your standard identification papers (driver's licence etc.) do not correspond to your apparent gender appearance, then, especially if you are liable to encounter officialdom, such as when you cross national boundaries, it is as well to be prepared.

The first way to be prepared, is to know your rights and the laws relating to cross-dressing in the territories you are entering. For instance, when entering Canada, you cannot be barred from entry because you are cross-dressed, or because you are (or are suspected of being) gay. TAM has copies of letters to this effect from Employment and Immigration Canada.

When entering the United States, the situation is different. The officials at the port of entry are federal officials (Customs, Immigration etc.). There are no federal laws against cross-dressing, according to the US Justice Dept. However, some states and cities have laws against disguise. At the border or airport of entry, you are controlled by federal immigration law, in particular the US Immigration Nationality Act, 1952 (at least you were in 1977). This law does not allow the entry of certain "excluded categories" such as criminals, persons with contagious diseases, and persons having a "sexual deviation" (section 212a4 of the above act). What is a "sexual deviation" you may well ask? Such terms are in practice interpreted by the history of court decisions in cases related to the act. R.H. Sweeny, the supervisor at the Champlain, NY crossing in Sept. 1977 (phone: (518) 298-3221) concluded after a 45 minute study of the legal library at that major crossing, that all the court decisions to that date had interpreted the phrase "sexual deviate" to mean "homosexual". So if you happen to not be gay and/or you can convince them to that effect, then you should have no trouble gaining entry (even in your sexiest outfit) provided you do not let them bluff you, and you show them that you have a knowledge of the specific section and paragraph of the relevant law. In my case, Sweeny advised me to carry a letter from a credible and qualified authority (such as my doctor) stating that I am a male heterosexual crossdresser, and hence imply that I am not one of the excluded categories.

Sweeny further informed me that just because one customs official at one border crossing turns you back to Canada, this does not mean that you have been excluded from entry to the USA. (A question they often ask you is: "Have you ever been excluded from entry to the United States?"). You are only excluded if you are presented with a written statement to that effect after appearing before a US immigration judge. The nearest such judges are located in Buffalo, NY; New York City; and Boston, MA.

Thus the second way to be prepared, is to carry appropriate documentation. A letter such as the above, from your doctor, is one possibility. One member of TAM obtained a letter from the chief of police of her home city, to the effect that she was of good character and had no criminal record or connections; and found this effective in crossing to areas where drug pushing is associated with cross-dressing.

Several US transvestite service/social organizations offer blank explanatory do-it-yourself identification cards (usually for about \$1), on which are printed blurb such as: "The person described on this card has what is medically known as gender dysphoria (i.e. in common terms is a transvestite or transsexual), and is not cross-dressed for fraudulent purposes but rather for personal happiness, peace of mind and self-expression." There is space left for identifying details, your masculine and feminine names and signatures and pictures, and for authorities to check with, such as your attorney or your doctor. Such cards are available from TWIC in Albany, NY; Shangri-La in Irvine, CA; and from the International Alliance.

The card from the International Alliance also serves as an Alliance membership card, so has to be renewed every year. The Alliance address shown on their current card is not up to date, since their national/international headquarters is in the process of moving to a different state this summer, so it is best to wait until they have printed new cards.

Once you have filled in the pertinent data, and attached the two photographs, you can enclose the card in clear plastic. Suitable self adhesive plastic sheets are available from machine dispensers in some shopping centres. One supplier: Seal-rite Plastics Ltd., Mail Order Dept., P.O. Box 400, Snowden Postal Station, Montreal, PQ, H3X 3T6 will send you 2 sheets each 10" x 12" of such material for \$2.00 (postage, but not provincial sales tax, included).

Cardinal Publishing Co. of P.O. Box 5200, Jacksonville, Fla, USA, 32207, will for \$5.00US make you up a very professional looking identification card. You send them your name address, "sex", height, weight, hair colour, eye colour, date of birth, and a small colour photograph, and they will send you your ID card "hot-sealed in long-lasting clear plastic" allegedly within 24 hours of receipt. I sent for mine on the 3rd and received the card back on the 27th of August. You can get your signature included on the card within the seal, by sending them your signature on a small self adhesive label at the time of your application. This card only shows a single gender role identity, and makes no reference to your gender dysphoria. I saw the ad for this service in Ms Magazine.

Black and white or colour photos made in an automatic photo-booth are adequate for most of these identification cards, if you want a close up of just the head to appear on the card. Cardinal trim the photo you send them to approximately 1" x 1 1/4" before placing it on the card.

If you do not want to appear to be naked, it is best to wear a top with a high neck so that it appears in the close-up trimmed picture. Alternatively you can send them a smaller "head-and-shoulders" picture, or even a "head-to-waist" picture, which ever you think shows you at your best. When having a friend take your picture for the purpose of the identification card, have them take you at varying distances from the camera, with different expressions and different backgrounds, so that when you get the prints, you can pick the happiest looking, and so that you have a choice of sizes to suit the available space on the card. Cardinal recommend a light background if possible for their cards.

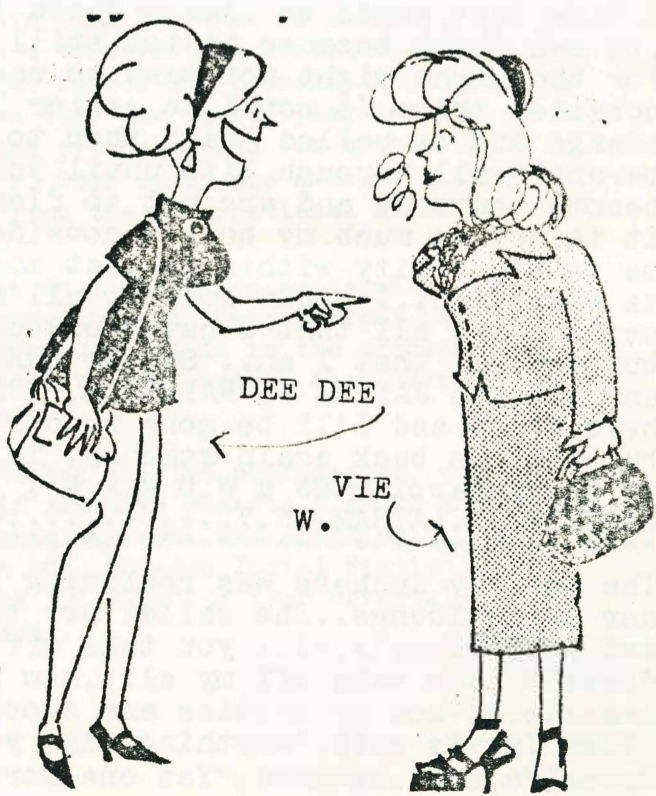
Dear Wilma:

ABOUT JOANNA: (Reported by The Gateway-495 Ellis St.-Suit 2507-San Francisco)

Articles highlighting Joanna M. Clark's continued feud with the U.S. Army and Navy Departments appeared in the Los Angeles Times on Aug. 21,1980.

Ms. Clark was a Chief Petty Officer in the Navy as a Male and served honorable for 15 yrs. Subsequent to her(his) release from the Navy, Clark underwent genital corrective surgery and later enlisted in the U.S. Army Reserve as a female. Having made full disclosure of her reassignment surgery and having undergone testing, both mental and physical, no different than that undergone by other enlistees, she was of the opinion that she would be allowed to serve her full enlistment and finally qualify for retirement.

Subsequent to her enlistment in the U.S. Army Reserve, Ms. Clark was asked to apply for civil service status and was accepted. Ms. Clark was moved into positions of both responsibility and authority and was transferred to fill position openings on the west coast. All seemed to be going well until 2½ years into her 4 year enlistment when in June 1977 Ms Clark was informed that "numerous allegations of misconduct" had been made against her. She later learned that the allegations included suchcharges as "drug addiction,immoral conduct, theft of classified documents, subversive activities and fraudulent enlistment." To show the seriousness of the allegations, Ms Clark was allowed to resign. (Had the allegations been true, she probably would now be in the slammer.) In July 1977 Ms. Clark resigned her position and fled to Hawaii to lick her wounds and reassemble her shattered life. It was during this period she felt she should fight back not onlt to clear her name, but get the retirement benefits due her.

Ms. Clark was never, as required by the legal code of the U.S. and the Constitution, confronted by her accusers nor was there ever a trial. All the actions were "administrative" and thus outside the bounds of legal happenings, Surely if Ms Clark had been in shape to think straight at the time, she would have stood her grounds and would now have this behind her. Of course from the security of her position she now can see this although at the time the pressures and the trauma were such that she was not thinking quite straight and was in no emotional condition to stand her ground and fight.

Since leaving the reserve, Ms. Clark has done a great deal for the transgender community. She has written several informative booklets concerning the legal aspects and rights of the transsexual. She has also become involved with the Gender Clinic at Dana Point and the American Civil Liberties Union. So, what appeared to be an ill wind really did blow some good.

We commend Joanna on her stand and the work she has done, and hopefully will continue to do, for the gender community. We know how "fighting city hall" can be and hope she doesn't get lost in the quagmire of bureaucracy.

MAN, BECOMING WOMAN, CAUSES JAILERS PROBLEMS:(Ottaway News Service)

WASHINGTON- Upstate New York police got a lesson in modern lifestyles recently when they arrested a person who claimed to be both male and female.

The individual, a New York City resident, was arrested in rural Putnam County on traffic charges. During questioning, the person revealed he was midway through a sex change operation from male to female.

"Evidently, he had already started taking hormone injections," said Putnam County Deputy Robert Warnken. Above the waist the prisoner was a female, and elsewhere still a male.
