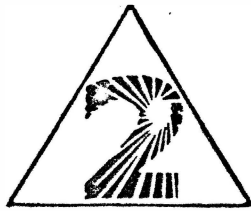

## CHICAGO TV ORDINANCE . . . . .

In the September, 1977, issue of the Femme Mirror it was reported that "The Illinois Court of Appeals has ruled that Section 192-8 of the Chicago Public Morals Code is not unconstitutional, resulting in the conviction of two defendants charged with violating the ordinance by 'wearing the clothing of the opposite sex with intent to conceal his or her sex.'" A survey of CHI Chapter members indicates that this is indeed "news" to all of us, since no one else had heard of or seen in any newspaper such a report. We consulted Carol Beecroft, Editor of the Femme Mirror, but she has been unable to locate the source of the item.
