With due thanks to Frances, it was decided to use the composite made by Dorothy, as the large number of ladies at the meeting are difficult to identify in the "official" photo...And, this is not the only change being made to accommodate growing attendance. Beginning with the May meeting two adjacent "changing" rooms will be rented.

...Patricia reminded all that no smoking was allowed in the Conference Room...The Chapter policy that members must be National members in addition to Chapter membership was repeated. New members must join the National within two months of becoming Chapter members. Chapter membership renewal will be denied those who do not join TRI-ESS. If a sister's particular financial situation is difficult, that does not prevent someone from joining us; the sister should speak with Lynda, Chapter Treasurer...Budgets. Revisions to the current year's budget were made to reflect latest experience and anticipated

activities through the fiscal year which ends June 30th. The current budget is now \$7540, up from \$5420 when the year began. The changes were approved with one revision; the advertising account was restored to \$300 to continue the VOICE ad through June. The Transfer to Reserves is reduced by \$132, and the estimated year-end surplus is now \$1670. The financial plan for 1985-86 totals to \$12560 (details provided in the Treasurer's Report). Sisters are encouraged to make their views known on the budget for next year, which maintains Chapter dues and meeting fees at current rates, and provides for expanded programs, advertising, and services. The new budget should be approved at the June meeting.

...Edie reported that 21 inquiries were received by her as a result of the VOICE ad campaign. More have been received through the end of April (30). The wording has been revised and will be run for another two months. Edie and the GALs are responsible for this recruitment effort...Ballots were sent to the membership for the election of Chapter Officers. They can be mailed to Patricia (Department E), or delivered to her at the May meeting. All qualified members should participate in this important Chapter function...Nominations for office were heard from the floor and Edie was moved and seconded for Secretary.

...A flyer on Family Day '85 was sent to the membership for their opinion on the format for this event. All are asked to return the questionnaire to Joann (NY, Queens), as soon as possible...Edie said that she sent for the transcript of the Channel 13 INNOVATION program on Sexual Identity; it will be available in the Chapter's Library...Barbara and several others went on another shopping trip to a nearby store that has been very understanding and helpful. She is trying to find a comparable establishment in New Jersey. No doubt a repeat trip is in store for the June meeting, so if you are interested come early. Barbara also organized a trip to the Latin Quarter's new femme

From the National Leader

"Concerning advertising 'open Groups' in the chapter newsletter, I think that advertising such 'open' organizations infers that they have our approval. Such is not the case, of course. These types of organizations include people who are bi-sexual, homosexual as well as those who are transsexual. Although we do not condemn such people for their different sexual persuasions, neither should we be put in the position of advertising their meetings. The reason for TRI-ESS being for heterosexuals only is that the members want it that way. In a survey several years ago, 87% of the members wanted TRI-ESS to be for heterosexuals ONLY. Let others do what they want, but we are only interested in heterosexual male crossdressers. Thus, to advertise such 'open' organizations is in direct conflict with the wishes of the vast majority of the TRI-ESS membership. Your President (we are now incorporated), has often referred 'different' crossdressers to GGA since that organization accepts such persons. So it is not a case of not caring about such individuals. But they have no place in TRI-ESS. I am sorry to state that a number of bi-sexuals get into the organization and when we learn of their homosexual persuasions, we have to let them go. Why such individuals join in the face of our statement in the brochure we send out, is beyond me.

All chapters should try to support the national organization in its policies. One of these policies is that non-members MAY attend three chapter meetings but then if they do not join the national organization, they cannot any longer attend the chapter meetings. It is a form of free-loading. If you pay your dues to the national organization, then so should others who attend your chapter meetings. If individuals cannot afford the dues, we are happy to carry such persons as members and they can pay later. So, there is no good reason why people shouldn't join the national organization. Do you think that you could join the local Elks Lodge and yet not be a member of that national organization? Same thing with TRI-ESS."

PROVIDENCE, R.I. (AP) — A high-heeled state worker wearing a knee-length fur coat and waving a warning sign is too distracting to motorists, the state Department of Transportation has decided.

So Santina DeSantis on Tuesday was ordered to don workboots and men's clothing and leave her muskrat coat at home.

"I'm stuck out here for eight, nine hours a day," the 42-year-old DeSantis said Tuesday. "I want to be warm, that's all."

As workers prepared to rip apart a Providence street to install underground communication wires, Ms. DeSantis stood near them, waving a red flag at passing motorists. She wore a hard hat, leather gloves, high-heeled shoes and the fur.

"It's just a plain old muskrat coat," she said. "I'd rather wear it than have it hang in my closet. I've been wearing it since the cold weather started," she said.

"I think it's a little distracting," said Anthony Ciacciarelli of the state DOT, which is overseeing the construction. He said DOT has told Local 271 of the Laborers' International Union of North America that its flaggers, including Ms. DeSantis, should dress down for work.

Gordon Cerow of DOT spoke to her Tuesday.

"He told me I should wear combat boots and jeans and I should wear men's clothes so I won't attract attention," she said.

A View From the Closet

I almost told her Thursday night. It was the best opportunity in our thirty-plus years of marriage and I may never get another chance like it again. But, - you guessed it - I chickened out. She asked me about it directly, but I lied to her to throw her off the track. In a way I feel that I have let down our chapter members and all others like us, but I had to be true to my long-standing and well-thought-out policy of keeping my exotic hobby a secret from my wife.

Thursday was my birthday and, to celebrate, we enjoyed a lieisurely dinner at one of our favorite restaurants. By the time we returned home, half of the prime time television shows were history and the evening movies were half over. My wife decided to watch the Merv Griffin Show. I picked up the newspaper and, as I so often do, tried to read the paper and watch television at the same time. Usually this attempt is doomed to failure, but an article on the first page of the science section caught my interest and I was able to "turn off" the television distraction and concentrate on my reading. The article was about genetics, specifically about the rare cases of human males with the female "XX" pattern of genes. After finishing the article I scanned the television guide to see what options we had for the 10 to 11 pm time slot. I noticed that HBO was offering a show entitled "What Sex Am I?". Looking in the cable television guide which we received at the end of last month, I discovered that the film was produced and narrated by Lee Grant and was an examination of the phenomenon of gender confusion. I cannot explain how I missed seeing the listing before this. When the monthly cable guide arrives I usually go through it pretty carefully.

As the Merv Griffin Show wound down my wife was getting drowsy and she suggested we watch the ten o'clock news so that we could get to bed a bit earlier than usual. I replied that I

wanted to watch HBO, and if she wanted to watch the news she could see it on our bedroom television set. When I told her what the HBO show was about, she asked me why I wanted to watch it. I didn't have to invent a lie this time; I told her that an article on genetics and sex in the evening newspaper had sparked my interest.

The film showed vignettes of the lives of several transsexuals and transvestites. While the stories of transsexuals were being told, my wife watched with interest and with hardly any comment. When the camera looked in upon a male transvestite donning his brassiere and stuffing it with padding, my wife asked, "You wouldn't do THAT, would you?" Her tone of voice told me what answer she wanted to hear. I said, "Well, I don't know. If it was for Halloween or a play, maybe."

My reply should have been, "Would you hate me if I did?"

I could have said facetiously, "Of course not. He's wearing a brassiere. I always use an all-in-one."

The best defense is a swift counterattack. I might have answered, "Who told You? It's a dirty lie! they can't prove a thing."

But, suppose I had told her, "Let's watch the show and we'll talk about it afterwards."?

Well, the golden moment passed. An ideal opportunity to finally come out of this closet evaporated in an instant. It had to be this way, however. Over the years my wife has given clear signals that she equates transvestism with homosexuality and that homosexuality disgusts her. In the long run I might gradually educate her on the true nature of heterosexual transvestism, but the subject rarely presents itself in our normal daily activities. For me to bring up the





ROGER'S NOTEBOOK

In the classical psychological literature, transvestism or cross-dressing is categorized as fetishistic behavior. Translated this means that wearing women's clothing (or some articles of women's clothing) by a male often results in erotic arousal for the wearer. In fact, this sexual arousal is one of the ways that transvestites are distinguished from transsexuals in clinical settings -- the transsexual is not usually erotically aroused by cross-dressing. Obvious, you say -- why are you telling me, a cross-dresser, this information? Why??? Because in many of my conversations with cross-dressers, they seem to deny this aspect of their cross-dressing, while using terms such as 'feeling good', 'more relaxed', and 'the clothes feel good'. To me, such statements imply sexual or sensual arousal, yet there is often vehement denial of any sexual arousal connected with the wearing of women's clothes.

One of the things that came out loud and clear from the women in my study was the erotic arousal that their partner's experienced when cross-dressed. About 70% of the men were reported as being highly or moderately excited when cross-dressed and 42% were reported as being more excited for sexual relations when they were cross-dressed than they were if not cross-dressed. When I add to this that 75% of the males sometimes or always cross-dressed for sexual relations, I am hard-pressed to deny the erotic component in cross-dressing.

OK, OK, I hear you saying, SO WHAT? The concern I have is that somehow feeling good while cross-dressed is seen somehow as bad! I find this a sad situation. I suspect that this attitude is, at least in part, a function of our social upbringing and custom. Many cross-dressers were originally 'hooked' because trying on women's or girl's clothes felt good. This good feeling may have led to an erection and perhaps orgasm. Then came guilt. However, guilt was not as strong as the good feelings and so the cycle repeated itself over and over. Somewhere later in time, many of you who are reading this were able to break the cycle and stop feeling guilty about cross-dressing. This did not stop the feeling good part of it, but it may have led you to deny that at least a part of the feeling good is sexual.

The whole point of this column is to provide you with a different perspective on your cross-dressing, namely that it is OK to feel sexually good while you are cross-dressed. There are too few things we have in this life that make us feel good -- to deny the few that do is sad.....

# At Bally's Park Place, boys will be—er, girls

UT THEY COME, one after the other—Marilyn Monroe, Barbara Streisand, Joan Rivers, Diana Ross, Ann-Margret, looking gorgeous. The sway of the hips, the nod of the chin, the rustling of gowns.

Women in the audience admire them. Men are in awe. They should be. After all, these girls are boys.

"La Cage Aux Folles" is the long-running female impressionist show running at Bally's Park Place Casino Hotel in Atlantic City. What began as a rather risky experiment (the casino crowd is decidedly not the Times Square transvestite crowd, folks) has become a rousing success.

Many in the audience go to "La Cage" (named after a Los Angeles club, not the Broadway show) to ridicule. Others actually think it's the

Broadway show. Some women go to giggle, some men to stare. Everyone is entertained though, because "La Cage" is a very slickly packaged show in which the alarmingly good look-alikes lip synch songs of the famous and carry it off brilliantly.

Most people go in skeptical. "This I've got to see," wailed one woman as she sat down at a show last week. When the show ended, she said she loved it. "Much better than I thought it would be," she said.

"Everyone's like that," laughed Drew Taylor, the actor who does a delightful impression of Joan Rivers and the only actor who uses his own voice.

"People think they're going to see a bunch of drag queens jump and grind. They don't expect the highly sophisticated show we put on. We're actors playing famous women. We bring our skills to this like we would bring our skills to playing famous men," said Taylor, launching into a performance and raps in his dressing room after the show.

Randy Allen, the actor who does a remarkable portrayal of Carol Channing, thinks changing times have helped female impersonators.

"Ten years ago, people saw us as just drag queens. Today, with the success of the 'La Cage' musical and the films 'Tootsie' and 'Victor/Victoria' they see us more as entertainers. Our image today is very good."

Some of the stars they impersonate have seen the show and loved it.

"Carol Channing told me I am a better Carol Channing than she is," joked Allen. "Liberace thought we were wonderful. Connie Francis has seen the show several times."

The stars spend one to two hours before the show getting made up. Before they start impressions at all, they research their star using movies, videotapes, records and even magazine and newspaper clippings.

"You've got to have the look," said Taylor. "A person's first reaction is, 'Oh, he looks just like her.' That's essential."

The performers are convinced, after doing various drag shows in the past, that impressions of certain stars work and don't work for different reasons.

"People connect certain well-known characteristics with impressions, like Streisand's nose or Channing's smile, Monroe's blond hair or Joan Rivers 'Can we talk?' routine," said Lindsay Lea, who does Streisand. "People are just not that familiar with new performers, so my Boy George, for instance, doesn't go over that well."

The women, er, men, in the show, are often propositioned by members of the audience. Taylor pushes a napkin across his dressing room table. On it is scrawled this message, "Jennifer and Steve, table 10. Would love to meet you after the show." Other messages the men get, Drew says, are more direct.

"Security keeps most people away here, but we get propositioned a lot in other places," said Randy Allen.

It's not by homosexuals, though.

"It's the women. Oh, the women," says Taylor, his eyes growing wide. "Women have this fascination with a man who's dressed as a woman..."

Despite the research and acting, though, "La Cage" succeeds, the performers say, for a basic reason.

"Everybody loves a drag show!" says Taylor. "We are a very sophisticated, talented show, sure, but the basic here is men as women. That's an illicit fantasy that has always intrigued audiences and always will."

"Crossdressing Cross-Country"

At 12:30 PM on the 14th of March I took one last look around before getting into my car to leave. I was sad and upset over this transfer, but looking forward to meeting some sisters on the way. With these thoughts on my mind, I pulled my car out of the driveway and headed toward California.

I arrived around noon on the 15th of March in Columbus, Ohio, and I phoned Eileen at work. She told me to stay where I was at, and she would meet me in 45 minutes. In the next 45 minutes I did some window shopping. The time seemed to go very slow, but finally Eileen arrived. She had a very bad cold, and had decided not to dress that evening. We talked for a few minutes, and then we took off for the place I would be staying. We had both agreed beforehand that I would be staying at Yvonne's place if I wanted to dress.

Yvonne's house is in an older section of Columbus, and I fell in love with her house. When I walked into the house, I felt I had returned to the early 1900's. She has done a great deal of work on her house, but the brightest aspect of the house was Yvonne herself. Her concerns and warmth makes one feel right at home.

Yvonne was already dressed when we arrived. We all talked for a few hours before both Yvonne and Eileen said I had better get ready. I was shown my room and two hours later came down the stairs to meet Yvonne as Karen. We talked for an hour, and then Eileen returned. Since she was under the weather, it was decided that we would not go out. I did learn that Columbus is a fairly safe town to go out dressed, but one also has to use common sense. Yvonne prepared a nice dinner for us, and we sat around the rest of the evening just talking. Before anyone realized it, it was 2 AM, so Eileen left and I went to bed. Yvonne let me sleep until I awoke which was around 10:30. She prepared a nice breakfast and I said goodbye. I will be very grateful to both Eileen

and Yvonne for their kindness.

I pulled out of Columbus around noon and arrived in Terre Haute, Indiana, at 5 PM. I called Shirley who had invited me to dinner several weeks before. She met me at the motel room at 7 PM, and drove me to her house. This gave me time to dress, and Shirley arrived dressed. Shirley's wife is a very understanding person, and it was an enjoyable evening. She drove me back to the motel around midnight and I remember thinking the evening was too short.

I left Terre Haute at 6:30 AM Sunday, the next day, and this was the only change in my plans. I was unable to visit Julie in Kansas City, Missouri. This was a sister I wanted to visit the most. I have written to her a great deal over the last three years, and I care about her. She is a sensitive person who has given me a lot of insight over the years. Yet, it was impossible to meet because I could not wait around until Monday evening since I had a meeting in California on the 22nd. As it involved my new assignment, and I could not reach Julie, I had to change my plans. I arrived that evening in Tulsa, Oklahoma and called Lisa of Oklahoma City; we agreed to meet on Tuesday evening.

I drove down the next day to Lawton, Oklahoma and saw several friends. This was the only time so far on my trip that I had not dressed, but I did go shopping early in the day and I found a nice new skirt. It was a denim skirt and it was cut to fall at my knees; I just fell in love with it. The following afternoon I left to meet Lisa at her house in Oklahoma City. I first met her there three and a half years ago, and I had helped her come out of the closet. She later told me that evening that I was the first crossdresser she had ever met. We had a very enjoyable evening, and later we took some pictures.

The following morning I left Oklahoma City in a heavy rain storm. The rain followed me the rest of the day, and as I got higher in the mountains, I ran into snow. I can laugh about it now, because I took the southern route to avoid the snow, and the northern route was dry and nice. I finally stopped at Grants, New Mexico. There was snow and dark clouds all around me, and I was tired. Since I was tense, I decided to dress that evening and I relaxed. I woke up the next day to 70 degree weather, and the sky was blue.

had to get up early the next day.

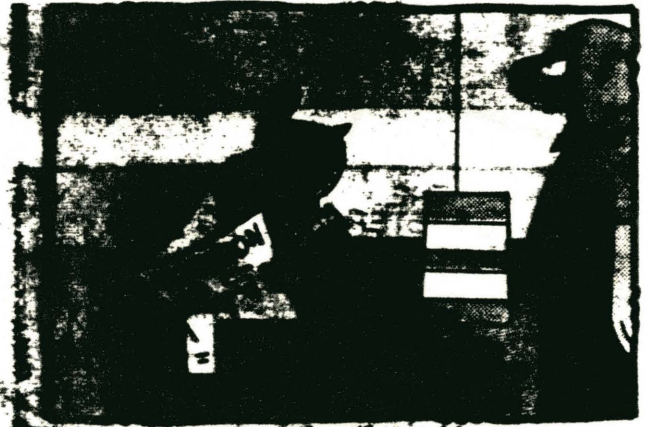

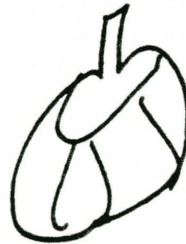
