**An Open Letter to Janice Bebe Dorn, M.D., Ph.D.  
Subject; "Gender Unique by Donna Hudson"**

Dear Dr. Dorn,

In the June, 1993, issue of **The Transsexual Voice**, an article called "**Gender Unique by Donna Hudson**" was published.

In the August, 1993, issue of **The Transsexual Voice**, you, Dr Dorn, wrote a response to the above mentioned article.

I was sincerely impressed, and grateful, that you took the time, and the effort, from your busy day, to write such an informative response.

Dr. Dorn, in your response to my article "**Gender Unique by Donna Hudson**", you wrote, "I am deeply moved by your letter, the sense of frustration you feel about not being understood by the medical profession and your intense suffering".

Dr. Dorn, the words that you wrote in the first paragraph of your response were the words that I have just quoted. Just by the words in that first paragraph, I felt some hope that perhaps there was someone in the medical profession who really could feel the suffering that I have lived with for so many years. I went on to read the rest of your 3 1./2 page response, and with each line, I felt that you were a professional who sincerely took an interest in what I had written.

The last paragraph that you wrote also had a very impressive statement in it. It was a statement that gave me hope. You wrote: "This is a fascinating letter and a fascinating concept which certainly would benefit from study and research. Of course the problem is, as Phoebe said, that most certainly society doesn't want to know about it. They may not--but we do."

Dr. Dorn, the words that you wrote "certainly would benefit from study and research", and "they may not--but we do", to me meant that you took an interest in this subject matter, and that you showed an interest in knowing more about it, and perhaps doing research on this subject, or at the very least, recommending a colleague who might be interested in doing research on this subject.

Dr Dorn, after reading your response to my article "**Gender unique by Donna Hudson**", I was up-lifted in my feelings, that perhaps I had found someone who did care, but how was I to know how wrong my thinking could be.

I decided to write you more on the subject in much greater detail. I wrote you a letter of some 20 pages and in two parts. Part One was mostly about how Donna came into existence, and what "she" is all about. Part Two, was about others who are involved in this subject matter of "crippled by choice". I also sent you a video about 1 hour 30 minutes. The video had three parts. Part One, was of Harry/Helen, the transvestite who is an amputee by choice. Part Two showed a genetic woman in her early 40's who is an amputee wannabe, with her leg tied up and on crutches, and Part Three showed a person who can fold his leg and put on an artificial leg and walk, like he needs the prosthesis to walk, and it also showed the same person as a crossdresser as a double amputee, and also as a crossdresser in leg braces.

Dr. Dorn, I felt by writing the letter, and sending you the video, and also the photos that I enclosed with explanation, would give you far more information on the subject than just the article "**Gender Unique by Donna Hudson**". In my letter to you I gave you every way possible to contact me. I gave you my phone number, my fax number, my America Online screen name, my Prodigy ID#, and my Internet address. In the last part of my letter I asked that you please let me know by any of the above means, when you received my mail.

Dr. Dorn, in very simple terms, I did not hear from you in any form. As your phone number was also published in your response in **The Transsexual Voice**, I did call and leave a message with your answering service. I did not get a response. I called a back in a day or two, and spoke to a female person who answered the phone. This person told me that you did get my message from your service, again no response from you. I called a third time, and left a message on your machine, and again no response from you. After writing you a very long letter, and three (3) times trying to contact you by phone, with no response, I again wrote you a letter, this time a short letter, and again no response.

Dr. Dorn, I took your response to my article "**Gender Unique by Donna**", seriously. I did not take your response as a joke. I spent the time, and took the effort, to write to you, and put together a video, that at the very lest would be informative. I assumed your response to my article was an indication of interest in this subject matter. Was I wrong for such an assumption on my part?

Dr. Dorn, I am sincerely interested in any comments that you have on the letter that I wrote you, and the video that I sent you. **What will it take to get a response from you?**

Dr. Dorn, your titles and degrees are very impressive, to say the least, but they are worthless to me, if after the many attempts that I have made to communicate with you, I fail to get a response of any kind.

In your response to my article, "**Gender Unique by Donna Hudson**", you wrote: "I would be very interested in the comments by Dr. Wollman and other readers". I did talk to Dr. Wollman over the phone for about an hour. I have sent Dr. Wollman mail via fax, but unlike you Dr. Dorn, Dr. Wollman has responded to me.

Dr. Dorn, I am still interested in hearing any comments that you would like to make on the letter that I wrote you, and also on the video that I sent you. I am also still very interested in research on this subject matter.

Dr. Dorn. If you do not have any intention of responding to my letter and video, please be kind enough to contact me, and tell me so. If you are not interested in this subject matter please tell me so. I feel that some kind of response, from you, to my efforts to communicate with you, would be nothing less then a common courtesy.

Dr. Dorn. I can send a full page letter across this country in about 52 seconds. How long will it take you to send me a response via fax, even if your answer is that you are simply not interested in any form of communication?

I hope to hear from you soon.

I have wrote several places, but still I find no straight answers to my questions. I was writing to a man through a personal that was telling me he could pay for my sex change operation. He stopped writing when he learned how serious I was. No one close to me will even talk about me wanting to become a man. I ordered a book from I.F.G.E. and was sent some horrible pictures of what I would call a deformed penis. Maybe you didn't expect such a letter, but if you can refer me to anyone I would deeply appreciate it. Lisa.

Dear Phoebe;

I cannot let the letter from Sandra F. in the August , 1993, newsletter go without comment. She made the following statement: . . . "A year of cross dress may be desirable for a young person who has not established a career, but it is impossible for those who are already in a profession." . . .

Although this may be Sandra's personal experience, research tells another story. The vast majority of transsexuals who have achieved success in professional fields are able to fulfill the year of cross living and remain in those fields. Those who have been successful, but decide to follow other career paths after their transitions, tend to continue to be successful in other careers after cross living for at least year. Certainly some transsexuals have difficulty with employers during a cross living period. That can be one of the unfortunate aspects of the dilemma. It is certainly less costly, however, to sacrifice a particular job than one's genitals if the test of cross living has not been met.

Sandra seems to raise objections concerning providers to transsexuals who lace medical training and are members of the Harry Benjamin International Gender Dysphoria Association.

I think it is worth pointing out that the person who was probably most responsible for the establishment of the Harry Benjamin International Gender Dysphoria Association and the first draft of the Standards of Care was the late Paul Walker, Ph.D..

Sandra F.'s, statement, . . . "It would seem that today there are more medicos helping patients with their transitions than are those knowledgeable about the 'Standards of Care'," . . . carries with it the implication that only physicians are capable of helping transsexuals with transitions while all others are not. I suggest that Sandra F. would be hard pressed to produce any evidence that even one hour of training of any sort is provided by reputable medical schools in this country concerning the physical or emotional treatment of transsexuality.

Sandra F. also seems to object to someone with a degree of Doctor of Education providing professional care and guidance to transsexuals. Frankly, I wish there were more people who had gained experience and knowledge of gender dysphoria who were interested in education. Not only can they help transsexuals to understand their dilemmas, but they are in unique positions to help others in society to understand the phenomenon and defuse some

of the stigma that is attached to the condition--a stigma which causes so much emotional pain for transsexuals and their loved ones. Certainly the stigma causes the kinds of problems Sandra raises with respect to cross living. We need more trained educators interested in the subject, not less.

Transsexuality is, after all, a condition of the mind with respect to assigned gender roles based upon the appearance of reproductive capability. One might choose a surgeon to alter the biology, but surgeons are not trained to deal with psychological anomalies that seem to reside in the mind. One of the benefits of the Harry Benjamin Association is that providers from various disciplines can come together and learn from one another in order to provide help for a very complex set of problems.

While the Standards of Care may provide some professional protection to providers who follow them, they are designed to shield people who find themselves in very vulnerable situations.

Dear Sir/Madam;

It is ironic that I chose to start this letter with the greeting that I did since it exemplifies my need to contact your organization. Just as I am not sure whether you, the reader, is male or female, I have doubts as to which gender I truly belong to.

Whereas the obvious lack of contact explains my doubt about you, the same can't be said for knowing about myself. Although born and raised quite normally as a male, I see at least a good part of myself much more as female. As a starting point I am hoping your organization can offer advice, support and information about my feelings.

My background is as follows: White "male", average height/build, 30 years old, middle class family with no dark secrets, parents divorced when I was seven (continued living in family home with mother?, one older brother. I began to be interested in women's clothes around puberty. Sneaking into my mother's underwear drawer eventually led to trying on her clothes. By last high school, etc. and began maintaining a limited wardrobe of female clothes. The sexual turn-on was enough at first but through the

years I've developed the desire to stop pretending I'm a woman and really be one.

Many of my natural attitudes point me in this direction. I have a lot of feminine traits such as being soft-spoken/passive, desiring lacy/frilly and delicate clothes, and in general having a demeanor that seems to alienate me from male friends and allows women to treat me as a friend they feel safe with (i.e. No masculine sexual threat, more like having a big sister around).

That's it. Can you offer any advice or contacts that could help clarify my situation. With all I've heard of it, transsexualism has gotten my attention and the more I see what it can do the more interested I become. I guess I need others' opinions. Anything you can offer will be appreciated.

Some of the other letters that appear in this issue of TSV may show you how much you have in common with other transsexuals.
