Business had been very slow in the lady's powder room until Barb entered. As soon as she went in I noticed at least twelve women suddenly descend on the place at the same time. the first to emerge from the powder room. She almost broke up laughing over the female conversations about their dates, etc.

The chefs, one for each grill, appeared and started their banter and showmanship with their carving knives and fancy techniques of preparing food. We knew it would be an interesting meal when our chef went around the table announcing what everyone had ordered. When he finished with Barb and I he exclaimed to the group "these two ladies get hamburger". Everyone chuckled since they knew we had ordered steak and lobster.

Everyone broke out their chopsticks and began to eat the salad. It was interesting to watch everyone trying to figure how to hold and manipulate them much less pick up the food. Having spent three years in the Far East I had learned the hard way how to use chopsticks. Everyone was probably aware the tall blonde at the end of the table knew her way around oriental restaurants. The meal, which is always the case with well prepared oriental foods, was very good.

After the cooking was finished the manager appeared, with several waitresses

We figured that surely if any doubt existed concerning our authenticity as females we could tell by actually talking to the entire group. Would you believe not one look of surprise, not one whisper, not one stare or look of curiosity? I was dumbfounded. I couldn't believe what had happened and was elated that we had really passed as far as the group was concerned. After settling our checks individually the group rose to depart. On the way out the manager ask if we had enjoyed our evening and ask us to come back again. We thanked him for his hospitality and a beautiful evening and headed for the door. #### PILOT SUIT FOLLOW-UP

A story concerning the \$4 million suit filed by Karen F. Ulane, a former Eastern pilot, against Eastern Airlines concerning her post-operative dismissal appeared in the December, 1981 Phoenix.

Ms. Ulane's case took a step forward on April 27 when Judge John F. Grady ruled, in the Chicago U. S. District Court that the Civil Rights Act of 1964, which protects citizens from sexual discrimination, applies to transsexuals as well as other minorities.

While this ruling is a step forward for Ms. Ulane's case it does not open the door for other pre- or post-operative transsexuals to seek shelter under the Civil Rights Act just yet. However when this case is appealed, and certainly it will be, the ruling, if upheld, will then be considered a legal precedent and a matter of law which will provide an umbrella of protection for the pre- and post-op venturing out into the world seeking employment. Hopefully, there will then be no more open discrimination based on expressed or implied transsexualism.

Of course to take advantage of this new "coverage" you have to be willing to stand up and be counted when your time comes. Employers tend, at times, to run roughshod over those thought to have no legal protection or who are afraid to express or demonstrate their legal rights. If you get a pink slip -- no dear not the wearable kind -- because of your transsexualism you will then have a legal precedent on which to base a claim to your job or acceptable compensation.

CLARK - 1, ARMY - 0

(March 20). Joanna Clark's four and one-half year battle with the U.S. Army ended this past week with an out-of-court settlement and the receipt of an honorable discharge.

Clark, the first person known to serve in the military as both male and female, served seventeen years in the U.S. Navy and U.S. Naval Reserve before being honorably discharged in 1974. Following sex reassignment from male to female in 1975, she enlisted, with full disclosure of her previous sex reassignment, in the U.S. Army Reserve in February 1976, as a Sergeant First Class.

In May 1977 Clark reprimanded a subordinate for a security violation at Fort MacArthur USAR Center, San Pedro, California. Two weeks later she became the target of a character assassination which led to the voiding of her enlistment and dismissal from the Service in August of the same year.

Clark, represented by the law firm of Giles, Stewart and Barnett filed suit in Federal Court in February 1978. The complaint was dismissed without prejudice and findings in 1979. Subsequently, acting on her own behalf, Clark filed a series of administrative appeals with the Naval Discharge Review Board, Board for Correction of Naval Records, Merit Promotion Protection Board and the Board of Correction of Army Records.

In August, 1980, ACLU staff attorney Susan McGreivy and ACLU volunteer attorney Jack Cate, filed a new complaint with the U.S. Court of Claims to stop the statute of limitations from expiring on Clark's action against the U.S. Navy and Naval Reserve.

Clark's appeal before the Naval Discharge Review Board, Board of Correction of Naval Records and the Merit Promotion Protection Board were remanded to the Court for lack of jurisdiction. Her appeal before the Board of Correction of Army Records was successful. The Board confirmed that an injustice had occurred and ordered Clark be given an honorable discharge.

The constitutionality of AR 40-501, which precludes appointment, enlistment or induction of persons having undergone sex reassignment was not resolved. The complexities of Clark's case, involving the Army, Navy and Merit Protection Board made it unlikely that Clark would prevail 5

without a lengthy and costly court battle. Consequently, it was decided to accept the Army's offer and settle the matter out-of-court.

Clark resides with her parents in San Juan Capistrano, where she currently operates a word processing service and participates as an activist in civil and human rights. An ACLU volunteer, Clark chairs the ACLU Transsexual Rights Committee.

#### MEDICARE AND SEX REASSIGNMENT

During the past few years there has been considerable confusion regarding whether or not Medicare will fund sex reassignment surgery and related therapies.

In 1978 the Office of General Counsel, Department of Health, Education and Welfare, reported that there were no explicit regulations prohibiting the use of federal funds for sex reassignment surgery and related therapies.

In October 1981, the Health Care Financing Administration, Department of Health and Human Services, issued Transmittal No. 883, which is referenced as 42 C.F.R. 405.310(k). The new regulation reads:

"Transsexual surgery is the culmination of a series of procedures designed to change the anatomy of persons who believe they belong to the opposite sex to conform with their believed identity. Although transsexual surgery has been performed for at least 50 years, it is still considered experimental because of the lack of long-term, properly designed studies of the outcome of the procedures demonstrating their efficiency. Moreover, there is a high rate of serious complications after surgery.

"Our decision not to cover transsexual surgery is based on the NCHCT's finding that there is a lack of well controlled long-term studies of the safety and effectiveness of the surgical procedures and attendant therapy for transsexualism; there is evidence of a high rate of serious complications of these surgical procedures; and the safety and effectiveness of transsexual surgery as a treatment for transsexualism are not proven and remain in question. The NCHCT

concluded, therefore, that transsexual surgery must be considered experimental. Their findings are based on the opinion of the National Institute of Mental Health of the Alcohol, Drug Abuse and Mental Health Administration, which conducted a literature review of the efficacy of sex change for the transsexual; an informational data base on transsexual surgery prepared under contract for HCFA by Health Information Designs, Inc.; and an NCHCT commissioned paper on the social and ethical aspects of transsexual surgery.

"Transsexual surgery for sex reassignment of transsexuals is controversial. Because of the lack of well controlled, long-term studies of the safety and effectiveness of the medical procedures and attendant therapies for transsexualism, the treatment is considered experimental. Moreover, there is a high degree of serious complications of these surgical procedures. For these reasons, transsexual surgery is not covered."

So, there you have it in a nutshell. Medicare will NOT pay for transsexual surgery.

This regulation could have been effectively blocked had there been sufficient funding available to provide a defense. Unfortunately, funding was not available and the bureaucracy scored another victory.

(Editor's Comments: It seems apparent, to us, that the crux of the denial of Medicare funding is the sentence of the above regulation which reads 'Transsexual surgery for sex reassignment of transsexuals is controversial.'

It also seems apparent that some bureaucrat decided "Since there isn't anything which prevents the expenditure of federal funds for sex reassignment surgery we had better find a reason to deny disbursement of funds to these weirdos. So, let's have some reputable contractor do a study on it for us."

And so, boys and girls, the big bad wolf in Washington D.C. contacted an unsuspecting bunch of outsiders, waved some money (actually the study completed by Health Designs, Inc. cost the taxpayer \$33,433.00) in front of them and they set to work like beavers on a new dam. And, boys and girls how did the beavers at Health Designs, Inc. find out about transsexualism, reassignment surgery and its attendant therapies?

Well, for one thing they sent a questionnaire containing 69 (coincidence?) questions to and "called upon a group of experts in relevant medical specialties (Obstetrics & Gynecology, Endocrinology, Forensic and Medicine, Psychiatry and Medical Psychology) and in the fields of Sociology and Bioethics, to provide clarification and technical direction on issues related to various aspects of transsexualism and sex reassignment surgery.

"These experts were selected because of their excellent professional reputation, technical knowledge and objectivity. Only one of the Project's consultants is currently involved in the treatment of transsexuals."

Golly, boys and girls, weren't they smart to select an objective "group of experts" who were not involved in the treatment of transsexuals? Of course, one "ringer" was slipped in, possibly to placate the TS community should this study fall into their hands. Presumably, if one is too close to, or directly involved in something their views of it tend to be subjective rather than objective (the old axiom of the lumberjack not being able to see the forest for the trees) and we wouldn't want "experts" with real knowledge of transsexualism and the transsexual as an individual participating in a study of that subject would we? After all they might arrive at a conclusion we didn't want.

We wonder, if the real intent of this effort was to provide meaningful, relevant information, why such luminaries in the fields of transsexualism and sex reassignment surgery as Paul Walker, Garrett Oppenheim, Sharon Satterfield, Drs. Biber, Huang, Wesser, etc. were not consulted. Why weren't post-ops, both successful and unsuccessful, consulted?

We obtained a copy of this report from one of our Senators in DC and have had it in our possession for over a year. The primary reason we have not brought it to your attention before this is quite simple -- everytime we open it we become so angry an objective review isn't possible and we usually have to head for the john so we can throw up without making a mess on the computer terminal keyboard.

During this year we will present sections of this study for your information and we will, of course, comment on each section as it is presented.

Dear Doctor Michelle,

Will birth control pills help me? Are they dangerous?

Dear Sister Mary Ann,

You're 47 years old in good health with no serious medical problems. Birth control pills, while containing minimum amounts of estrogen, may be of use to you. In his book, THE TRANSSEXUAL PHENOMENON, Dr. Harry Benjamin recommends hormonal therapy for more comfort from stress in the Grade 4 Crossdresser (a serious TV or borderline TS). Since I know you are borderline between a very serious TV and a questionable TS. I think some mild hormone therapy, such as birth control pills, would be useful to you. The action of these hormones is relatively light but should be appreciated. You may find a slight to moderate degree of nipple tenderness and minimal growth. The birth control pill absolutely will not cause the development of female breasts, but you will have a degree of sensitivity in that area. It will also probably make you feel better about yourself in addition to slightly reducing the amount of circulating testosterone and thus helping to calm, to a slight degree, your aggressiveness. It will bring you much pleasure by being able to take a very feminine medicine.

I think you will also have to consider

the "placebo effect" of the pill. If I were to present you with a sealed package of "birth control" pills which really contained nothing but sugar pills you would derive some benefit from that -- the psychological benefit would still be there -- and you would not experience any risk. The risks of the birth control pill are slight for you. Basically I state to women when I give them The Pill that it is 15 times less likely to kill them than having a baby is. It is, relatively, a very safe medicine.

Now, considering that you do not have many of the anatomical risks that a female does when she takes these pills the risks are very slight for you. Also you have testosterone which will counteract many effects of the pill. I think, for a healthy FTM crossdresser, the pill has very few risks. However, should you develop diabetes, high blood pressure, or liver disease I would, based on laboratory studies, recommend immediate discontinuance of the pill. Prior to commencing taking the pill I strongly recommend having a full physical examination and lab studies to rule out any of the problems that would make the pill more hazardous.

Dear Doctor Michelle,

I am 54 years old and a long-term crossdresser. I have not had a physical examination in 10 years -- I'm afraid to do so because I've had full body electrolysis and I'm afraid the doctor doing the examination would ask embarrassing questions. I'm very well known in my community and cannot afford the risk of embarrassment. Can you help me?

Dear Betty,

Your situation is not all that unusual. Many crossdressers are embarrassed about showing a doctor their feminine nature. In most cases the doctor never notices since he/she is looking for things other than signs of crossdressing. Besides, very few doctors are knowledgeable enough to put the pieces together to come up with the picture of a crossdresser. I would suggest that unless you had a bikini line on your tan your doctor probably would not figure it out.

However, if you really do need a physical my suggestion is to contact a

gay physician in your area through the local gay newspaper. Gay physician's groups exist in every major metropolitan area of this country and a gay physician, in addition to probably being an excellent doctor, will probably be very understanding about your problem. I would have no reservation at all about asking a Gay Physician's group in your area for someone to see. Explain the problem in confidence and I'm certain you will find a physician with whom you can be comfortable.

(Note: Betty did come to see me and during the examination I found high blood pressure which was somewhat serious. I have been treating her for better than a year and Louise's risk of having a stroke have been reduced considerably and she is now under the care of an understanding physician in her own area.)

Dear Doctor Michelle,

At the insistence of my wife I recently had a psychiatric evaluation done at a major university center here in Philadelphia. The physician in charge diagnosed my condition as transvestism (a 3 on the Benjamin scale of 6) and suggested I undergo a long course of psychotherapy in order to cure this condition. He said it would take between 2 and 4 years of weekly visits to attain this end. What is your opinion?

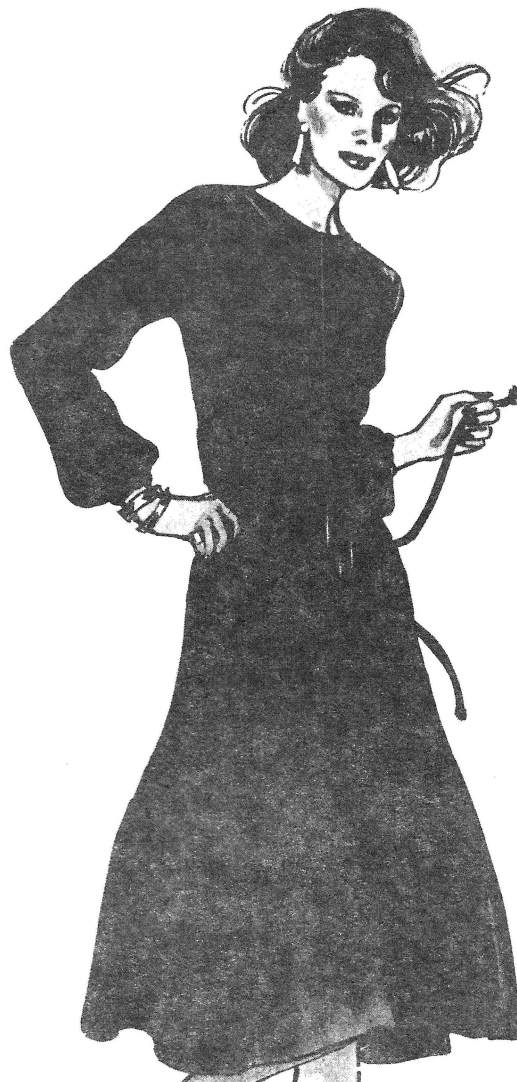
Dear Phyllis,

Though the psychiatrist of whom you're speaking is well regarded in his field I believe, in your case, he is off base.

In the first place if you don't want to be cured of the transvestism -- most of us don't since crossdressing is one of the great joys of our lives -- the psychotherapy will not work. Unless there is some other condition, outside of crossdressing, for which you really do require therapy I don't think it is advisable.

You are a well adjusted TV living in a marriage situation where your crossdressing is not accepted. I believe a better solution for you is to join a group, such as our Chapter, and put yourself in the company of others who share your feelings and can provide you with reassurance and companionship.

Psychotherapy would attempt to convince you that crossdressing is wrong or that it is bad for you. The behavior modification techniques which would be used could be ultimately more damaging to your psyche than almost certainly is crossdressing which, in and of itself, is a healthy variation of human sexuality. There is nothing wrong with crossdressing, rather the society in which we live is wrong by placing a moral judgment on those of us who crossdress. Your marriage situation seems to be the problem and the resolution will have to come in another way than for you to cease crossdressing. Frankly, I doubt seriously that you will be able to stop completely and for all time.

This is in response to your letter of March 22, 1982, regarding the Electroh hair removal device.

The Electroh is an electric tweezer epilator. It is the opinion of the Bureau that electric tweezer epilators are no more effective than mechanical tweezers. Further, we have seen no well controlled scientific documentation to show that these types of devices will result in permanent hair removal. Since evidence is lacking, the conclusion of the Bureau is that claims for such effectiveness have no basis in fact.

I trust this answers your inquiry.

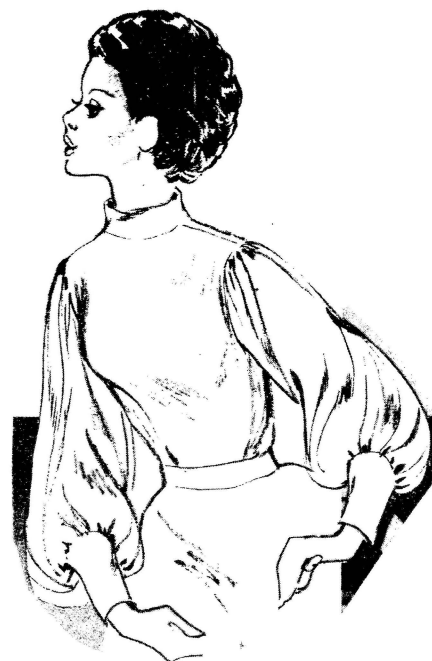

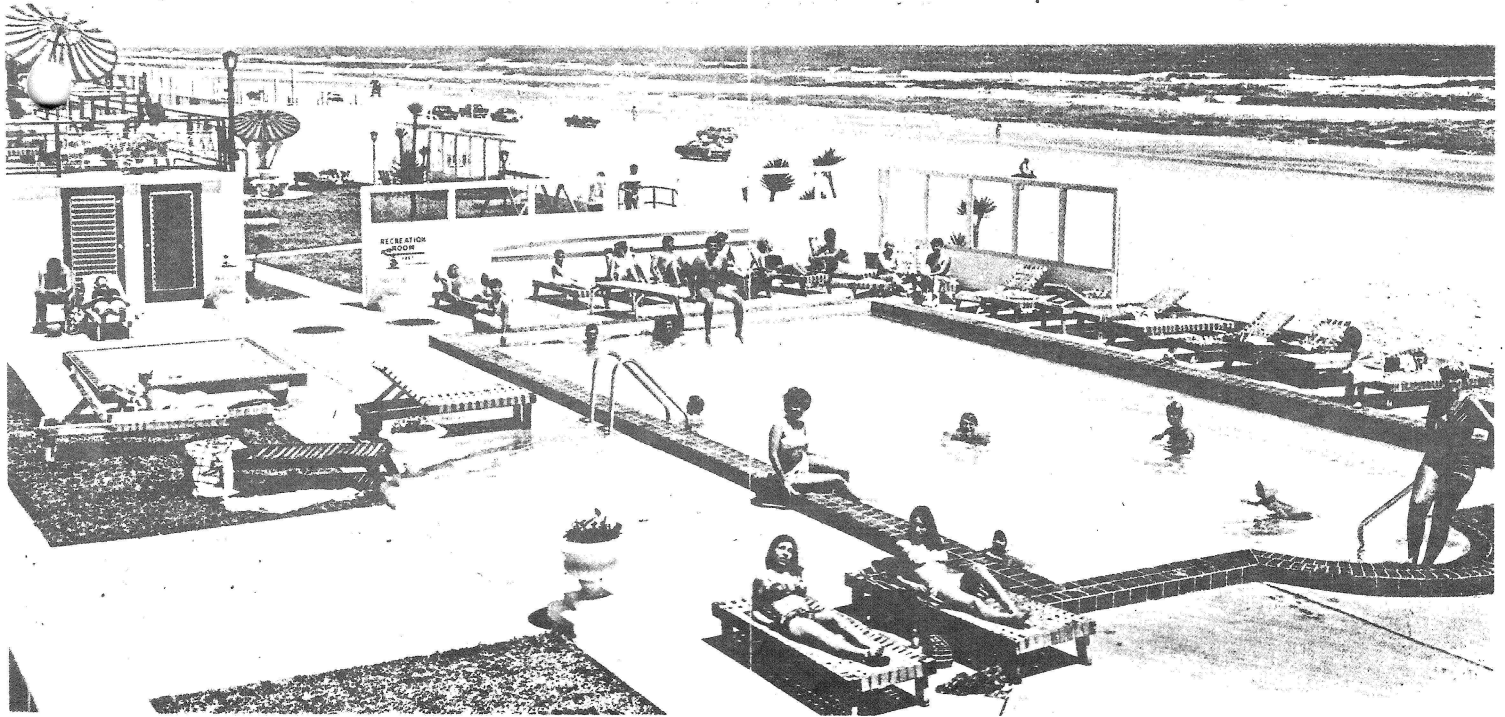
